

# TOWN OF VAN HORN WATER RATES

The following water rates were adopted at the City Council meeting of the Town of Van Horn, held on March 29, 2019 to be effective with the April 01, 2019 billing:

1. **RESIDENTIAL: INSIDE CITY LIMITS**

Bad Credit History	\$ 25.00 Increase on existing deposit for each turn-off for non-payment after the first instance.

7. **SEWER TAPS: based on Water Meter Size**

Residential Tap: Single Family	\$ 200.00
Commercial Tap (Under 1" Meter)	\$ 250.00
Commercial Tap (1" Meter)	\$ 300.00
Commercial Tap (2" Meter)	\$ 500.00 Minimum. Plus \$50/Public Toilet Stall/Urinal and/or LUE
Commercial Tap (Over 2" Meter)	\$ 750.00 Minimum. Plus \$50/Public Toilet Stall/Urinal and/or LUE. Varies based on actual material and labor costs.

8. **SERVICE CHARGE**

All Service Calls \$ 25.00 To be applied to all customer requests for service, including but not limited to: water meter turn-ons and turn-offs, meter checks, sewer checks, re-readings, etc. [City error will not cause service charge to be assessed to customer.]

9. **DELINQUENT FEES**

Delinquent Fee \$ 25.00 To be applied to all accounts cut-off for non-payment. All bills are due and payable when billed. Any payment not received by the 15th of the month will be considered delinquent and subject to termination of service without further notice. Residential and commercial accounts are cut off if delinquent after the 5th of the following month.

10. **PENALTY**

Penalty 5% A five (5) % penalty will be assessed on all accounts whose payments are not received in our office by 5.00 p.m. on the 17th day of the month.

11. **HANDLING FEE**

Handling Fee \$ 25.00 For returned checks.

12. **MISCELLANEOUS FEES**

Cut-off valve replacement \$ 30.00 To replace broken cut-off valve. A Service Charge will be assessed for this service.

Inspection: Backflow preventors \$ 60.00 For annual inspection of backflow prevention assemblies.

Meter Testing \$ 25.00 Administrative Fee Plus Actual Cost of Testing and Shipping/Handling

13. **HUDSPETH COUNTY JOINT WATER SYSTEM**

Cost per 1000 gallons Varies Amount to be determined semiannually from special report compiled by auditors. Effective each January and July.

14. **WATER/SEWER EXTENSIONS: Existing Residential Developments**

Actual cost of materials, labor and equipment based on established hourly rate.

15. **WATER/SEWER EXTENSIONS: Commercial/Voluntary Annexations/ETJ**

Actual cost of materials, labor and equipment based on established hourly rate.

16. **WATER/SEWER EXTENSIONS: New Subdivisions**

To be provided by developer in accordance with TCEQ specifications. After acceptance by Town, Town will own and maintain lines. [Requires site development plan.]

17. **SENIOR CITIZEN RATE:**

Residential customers aged 65 and over may be eligible for a \$5.25 reduction on the base rates for water and sewer services. Eligibility requirements for this rate and application forms are available at City Hall.

18. **SPECIAL ASSESSMENT: WATER TANK**

Residential Customers: \$ 1.00 Special Assessment for new Water Tank. For this F/Y only.

Commercial Customers: \$ 2.00 Special Assessment for new Water Tank. For this F/Y only.

Residential Tap: Single Family	\$ 150.00 plus materials listed under miscellaneous fees
Commercial Tap	\$ 150.00 plus materials listed under miscellaneous fees for standard size meter.

7. **SERVICE CHARGE**

All Service Calls	\$ 25.00 To be applied to all customer requests for service including but not limited to: meter turn-ons and turn-offs; meter checks, re-readings, etc. [City error will not cause service charge to be assessed to customer.]
Shut-In Test	\$ 25.00 Leak Detection Procedure
Carbon Monoxide Test	\$ 25.00

Delinquent Fee	\$ 25.00 To be applied to all accounts cut-off for non-payment. All bills are due and payable when billed. Any payment not received by the 15th of the month will be considered delinquent and subject to termination of service without further notice. All accounts are cut off if delinquent after the 5th of the following month.

Residential customers aged 65 and over may be eligible for a \$4.00 reduction on the base rates for natural gas services. Eligibility requirements for this rate and application forms are available at City Hall. Seniors will not pay Surcharge.
